Health Center Frequently Asked Questions (FAQ)

Upon attending Lynn University are there any forms that need to be completed?

Required Health Documents for ALL incoming Freshman, Transfer and Graduate students

- 1. **Health History & Authorization for Treatment form** (completed by the student)
- 2. Proof of a *Physical Exam* within one year of enrollment at Lynn University
- 3. Immunization Records
 - a. MANDATORY FOR ALL: Series of two MMR (Mumps, Measles, Rubella) vaccines.
 - b. MANDATORY FOR ALL STUDENTS LIVING ON CAMPUS: Meningitis vaccine within 5 years of beginning of the 1st semester living on Lynn's campus.
 OPTIONAL FOR COMMUTER STUDENTS, however a Meningitis waiver must be signed if proof of vaccine is not on file.
 - c. OPTIONAL FOR ALL: Hepatitis B series of three vaccines. A waiver may be signed to decline vaccination. Must have proof of vaccines or waiver signed by the student
 - d. Proof of Insurance is required for all students.



Do I need to have health insurance? Does Lynn offer student health insurance?

Yes, Lynn University requires all students to carry health insurance.

All students enrolled must complete the online health insurance verification process by the assigned deadline. Students who fail to complete the verification by that deadline will automatically be enrolled in, and charged for, the Lynn University Student Health Insurance Plan offered through AIG, Educational Markets. No exceptions will be made.

It is mandatory for all students to log on to the AIG website to do the following:

- 1. If you already have health insurance. You must complete the insurance waiver on the AIG website to opt-out. Please have your insurance information at hand.
- 2. If you do not have health insurance, you have the option to complete the Hard Waiver to enroll in a Lynn student insurance plan through our provider, AIG.

If you do not provide Lynn with proof of insurance, you will be automatically enrolled and your Lynn student account will be charged \$1,120 for an applicable AIG plan.

What are the Health Center hours?

Our regular hours of operation are Monday through Thursday 8:00 a.m. to 8:00 p.m. and Fridays from 8:00a.m. to 6:00 p.m.. Please call for summer hours. We are closed on the weekends.

Is the Health Center open during breaks?

We are open for summer, J-term and Spring break. We are closed for Winter break, Thanksgiving and most other major holidays.



Are there nurses, nurse practitioners, and/or doctors on campus?

Yes, during the Fall & Spring semesters, we have two full-time Registered Nurses and one part-time Nurse Practitioner on staff. During the summer, our Nurse Practitioner is out of the office.

How do students get their prescriptions filled? What pharmacies are near the campus, and what if I am unable to go to the pharmacy to pick up my prescription?

We do not have a pharmacy on campus. There are many local pharmacies (Publix, Walgreens, CVS, etc.) to accommodate your pharmaceutical needs. Please contact the Office of Student Involvement (OSI) for the free off-campus shuttle schedule, should you need transportation assistance.

Is there someone to ensure that my child is taking their daily medication?

No, your son or daughter is responsible for administering their own medication.

Where is the closest hospital?

The closest hospital is the Boca Raton Regional Hospital, 2 miles away from campus.

What vaccinations are offered on campus? What is their cost?

Our most commonly administered vaccines are MMR, Hepatitis B, Meningitis, Gardisal, Influenza, and Tetanus-Diphtheria. Please call ahead to schedule an appointment should you have a vaccination need, or to find out more information regarding other vaccines.

What are the fees associated with the Lynn University Health Center?

We do not charge for office visits; however there will be a fee if lab work is done either from us or by your insurance company.

What forms of payment are accepted in the Health Center?

We only accept cash or check. Debit/credit cards are not accepted. If necessary, a student may charge their Health Center balance over \$20.00 to their Lynn student account, and pay their student account via debit/credit card.

What if there is an emergency after hours?

Does my child need to find a doctor local to Lynn?



Our Nurse Practitioner can treat most minor illnesses. We suggest coming to see us first to minimize costs, since there is no visitation fee or co-pay. However, if the student needs a referral, we are happy to refer them as needed.

Does the Health Center cover all medical needs?

We treat acute & minor injuries and illnesses, physical exams, lab drawings, vaccines, sexual health screenings, well-women's exams, off-campus physician referrals and health promotion materials. Our Nurse Practitioner is available by appointment.

Do I need to make an appointment before going to the Health Center?

It is recommended that you call ahead to schedule an appointments. However, we do accept many students on a walk-in basis.

Will parents be notified if a student is ill? Who has access to the student's medical record?

Students over 18 years old are the only ones who have access to their records. They can sign a record release form if they would like for us to be able to release any information to a parent or guardian.

Do you perform testing for Sexually Transmitted Disease/Infections (STD/STI)?

Yes, we do offer STD/STI testing for a subsidized price. Please call or come by the office for information on current costs.
