All Full-Time, Day-Students, International Students, and Graduate Students living on campus are automatically enrolled in the Lynn University Health Insurance Plan. The premium for coverage is added to the students tuition bill, unless proof of alternate coverage is provided.

- From the Lynn University page you can waive by clicking the blue button located in the Waive section;
- Follow the on-screen instructions to waive out of the student health insurance plan.
